#### 1. Introduction

MeetAgain ("App", "we", "our", or "us") is a social discovery platform designed to connect people through real-world places and experiences.

This Privacy Policy explains how we collect, use, store, and protect your personal data when you use the MeetAgain mobile app and the website meetagain.now (the "Website").

By using MeetAgain, you agree to the practices described here.

#### 2. Data We Collect

We collect and process the following categories of data to provide our services:

- Identity Data: name, gender, age (derived from date of birth).
- Contact Data: email address (used for login and communication).
- Profile Data: photos, description, and content you upload.
- Location Data: approximate location for Check-ins and MeetPoints (never tracked in real time).
- Communication Data: messages exchanged with other users.
- Transaction Data: Vibes purchases made via Apple In-App Purchase.
- Technical Data: IP address, device type, operating system, and standard HTTP server logs.
- Website Data: cookies, IP addresses, and analytics from the website meetagain.now.

We do **not** collect or process biometric data directly.

Photo verification is performed through a third-party provider that compares a live selfie with uploaded photos, returning only a verification status (verified/unverified).

# 3. How We Use Data

We process data only to operate, improve, and secure our services:

- to create and maintain your account;
- to display and manage Check-ins, MeetPoints, and Requests;

- to process payments for Vibes;
- to ensure safe user interactions and detect fraud;
- to provide personalized recommendations and show nearby events or places;
- to communicate with you about updates, new features, and relevant promotions;
- to comply with legal obligations.

We do not sell or share personal data with third parties for advertising purposes.

# 4. Legal Basis for Processing (GDPR)

We process your data under the following lawful bases:

- Performance of a contract: to provide MeetAgain's core features.
- Legitimate interest: for security logs, analytics, and service improvements.
- Consent: for optional photo verification and cookies.
- Legal obligation: where processing is required by law.

# 5. Data Storage and Security

Your data is securely stored on Amazon Web Services (AWS) Frankfurt, Germany.

All data transfers use HTTPS/TLS encryption.

Access to databases is strictly limited to the Chief Technology Officer (CTO) and authorized administrators.

We maintain technical and organizational measures to prevent unauthorized access, loss, or misuse.

#### 6. Third-Party Services and SDKs

MeetAgain uses the following third-party integrations:

- Google Maps / Places API / Sign-In to display maps and locations.
- Facebook Login SDK for optional sign-in and analytics.
- **Pushy** to deliver in-app notifications.
- Photo Verification Provider for automated user authenticity checks.

All providers operate in compliance with the **General Data Protection Regulation (GDPR)** and process only the minimum required data.

### 7. Cookies and Website Analytics

Our website meetagain.now uses cookies and similar technologies to analyze traffic, measure engagement, and improve performance.

We collect: IP address, browser type, visit duration, and referral sources.

Users can accept or decline cookies via the on-site cookie banner.

# 8. Marketing Communications

We may send occasional emails to inform users about updates, features, and relevant promotions.

You can unsubscribe at any time by clicking the "unsubscribe" link in each email or contacting support@meetagain.now.

We never send unsolicited marketing messages.

# 9. Recommendations and Local Discovery

We may use anonymized and aggregated usage data (e.g., frequent Check-in or MeetPoint activity) to improve local recommendations and suggest nearby venues or events.

Precise location data is never shared with third parties.

#### 10. Account Deletion and Data Erasure

Users can permanently delete their account directly from within the app via the "Delete Account" option in settings.

Upon confirmation, all personal data — including profile details, photos, messages, MeetPoints, Check-ins, and history — is immediately and permanently deleted from our servers.

No backup or recovery period is retained.

#### 11. Data Retention

- Check-ins are automatically deleted after 1 hour.
- MeetPoints are automatically deleted after 72 hours.
- Requests remain active until responded to or deleted by either user.
- Technical logs are deleted after a short retention period necessary for system security.

#### 12. Children's Privacy

MeetAgain is strictly intended for users aged 18 and older.

We do not knowingly collect data from minors. Accounts found to belong to users under 18 will be deleted immediately.

#### 13. International Data Transfers

Data is stored and processed within the European Union.

If data must be transferred outside the EU in the future, it will be done in accordance with GDPR and using appropriate safeguards (e.g., Standard Contractual Clauses).

# 14. Corporate Changes

In the event of a merger, acquisition, or corporate restructuring, user data may be transferred to the successor entity, provided that the same level of data protection is maintained.

# 15. Your Rights

Under GDPR and CCPA, you have the right to:

- access, correct, or delete your data;
- request a copy (data portability);
- withdraw consent at any time;
- object to data processing for legitimate interests.
