

MeetAgain – Terms of Use (EULA)

1. Introduction

These Terms of Use (“Terms”) constitute a legally binding agreement between you (“User”) and Ilia Zaitsev, a registered sole trader in Slovakia (“Developer,” “we,” “us,” or “our”), regarding your access to and use of the MeetAgain mobile application and related services (the “App”).

By downloading or using the App, you agree to these Terms. If you do not agree, please do not use the App.

2. Eligibility

MeetAgain is intended for individuals aged 18 and above. Users must enter their date of birth during onboarding; accounts belonging to persons under 18 are not permitted or processed. We do not knowingly collect data from minors.

3. Account and Access

You may sign in via Single Sign-On (SSO) using Apple ID, Google or Facebook. You must provide accurate information and are responsible for maintaining the security of your account. We may suspend or terminate accounts violating these Terms or our Content Policy.

4. Core App Features

Check-ins – temporary location markers active for 1 hour and deleted automatically after expiry. Users choose explicitly when to share location.

MeetPoints – user-created posts about places visited or planned. Active for up to 72 hours and removed automatically unless deleted earlier.

Requests – paid first messages that allow users to start a conversation. Each Request costs three Vibes. Subsequent messaging is free. Requests remain visible until a recipient responds or either party deletes it.

Push notifications inform users about relevant activity (Check-ins, MeetPoints, Requests). Notifications can be disabled at any time.

5. Vibes – Virtual Currency

MeetAgain offers a virtual in-app currency called “Vibes.”

- Vibes can be purchased only via Apple’s In-App Purchase system and used solely within the App.
- Vibes cannot be exchanged, transferred, or converted into real currency.

- Vibes may be offered free as a bonus to new users.
 - All purchases are final and subject to Apple's billing and refund policies.

6. User Content and Behavior

Users may upload photos, text, and other content visible to others within the App.

You must not upload offensive, illegal, misleading, or infringing content.

You may report other users via the "Report User" function or by contacting support@meetagain.now.

We may remove content or suspend accounts that violate these Terms or our Content Policy.

7. Photo Verification

MeetAgain offers optional photo verification to enhance trust and safety. Verification is performed by a third-party provider that compares a live selfie with user-uploaded profile photos. Only verification status (verified/unverified) is stored. We do not store or process biometric data directly.

8. Payments and Refunds

All payments are processed exclusively by Apple through the In-App Purchase system. MeetAgain does not store or process credit card information. Refunds are handled by Apple under its own refund policies.

9. Privacy and Data Handling

Personal data is processed in accordance with the [Privacy Policy](#).

- Data storage: AWS Frankfurt (EU).
- Third-party SDKs: Google Maps SDK (for maps and places) and Facebook SDK (for sign-in and analytics).
- Data retention: until user deletes the account or content.

We do not sell, trade or share personal data with third parties.

10. Termination and Account Deletion

You may delete your account at any time through the App or by contacting privacy@meetagain.now.

Upon deletion, your profile, MeetPoints, Check-ins and messages will be permanently removed from our servers.

11. Limitation of Liability

MeetAgain is provided "as is." We do not guarantee uninterrupted operation or error-free performance. To the maximum extent permitted by law, we are not liable for indirect, incidental, or consequential damages arising from the use of the App.

12. Governing Law and Jurisdiction

These Terms are governed by the laws of the Slovak Republic and the European Union.

Users outside the EU may have additional rights under local laws (e.g., CCPA in California). Any dispute shall be subject to the exclusive jurisdiction of the courts of the Slovak Republic.
